As of 6/30/2019, GROW South Dakota only owned and leased one school building.

4b (Code: ) (Expenses \$ 1,453,026. including grants of \$ 404,867.) (Revenue \$ 190,839.) Housing: GROW South Dakota owns a 60 unit HUD property in Milbank, South Dakota. The project is currently managed by Mills Property Management and consists of 30 one-bedroom elderly units and 30 family two- and three-bedroom units in townhouse structures. The organization made 156 on-balance sheet housing loans totaling \$1,720,158 and 11 off-balance sheet down payment housing loans totaling \$80,000.

Business Revolving Loan Funds: In FY 2019, GROW South Dakota made 14 business loans totaling \$907,000, creating or retaining 36 jobs through the Revolving Loan Fund.
