4b (Code:) (Expenses \$ 1,380,187. including grants of \$ 691,895.) (Revenue \$ 200,975.) Housing: GROW South Dakota owns a 60 unit HUD property in Milbank, South Dakota. The project is currently managed by Mills Property Management and consists of 30 one-bedroom elderly units and 30 family two- and three-bedroom units in town house structures. The organization made 141 on-balance sheet housing loans totaling \$2,018,595 and 22 off-balance sheet down payment housing loans totaling \$101,200. The organization also assisted 57 home owners with housing rehab on existing property that totaled \$666,465 in repairs.

4c (Code:) (Expenses \$ 144,163. including grants of \$ 13,500.) (Revenue \$ 411,290.) Business Revolving Loan Funds: In FY2021, GROW South Dakota made 12 business loans totaling \$1,332,527, creating or retaining 55 jobs through the Revolving Loan Fund. The organization provides technical assistance to all applicants.
